## <u>Utah Medicaid – Provider Enrollment for EDI Transactions</u>

As of April 1st, 2023, Utah Medicaid began enforcing provider enrollment requirements to submit HIPAA EDI transactions.

Providers must complete the outlined enrollment process within Utah Medicaid's PRISM system to associate their accounts with the FinThrive (FKA TransUnion Healthcare) PRISM ID and UHIN Trading Partner Number (TPN) for their selected HIPAA EDI transactions.
